

DEFINITIONS

"Voxcall[®]" refers to a Service created by the company Profit Target LDA, registered under the number NIPC 515959731, with a share capital of €5000, including its directors, administrators, employees, agents, and affiliated entities.

The Service named Voxcall[®] is designed to optimize business communication strategies through artificial intelligence.

TERMS & CONDITIONS OF SALE

Article 1: Service Presentation

Voxcall[®] enhances telephone interactions through a sophisticated programmable platform that allows launching voice calls with artificial intelligence directly online from the Voxcall[®] website via a form and using a personal identification code. For specific projects, Voxcall[®] offers an internal call service on request.

Article 2: Access and Identification

2.1 Account Creation

Customers must register directly from the online form, with free access, providing a valid phone number and email address, which will be used as identity references along with the first and last name. Account validation is completed by receiving a unique personal code, sent by SMS to the provided phone number. This personal code will be required for all uses of online forms, whether for Free access, the Discovery formula, or the Professional form. It will not be possible to associate another phone number with the same email address and vice versa.

2.2 Account Security

The customer is responsible for the security of their account, particularly their personal code. In case of forgetting the personal code, it will be sent directly to the mobile associated with the email address from the personal code request form.

Article 3: Subscription and Financial Conditions

3.1 Subscription

Fixed purchases and annual subscriptions are offered, with specific details provided on the Voxcall $^{\mbox{\scriptsize R}}$ site.

3.2 Functioning of Plans

Free Access

This is the basic formula that only offers a limited number of free calls after creating one's personal usage code.

Discovery

The Discovery plan is available at \in 0/month/year because it allows for one-time top-ups with variable amounts. The specifics of whether to leave the amount as an open field or to provide set options are still under consideration.

Professional

The Professional formula allows the use of a large number of options and calls on a specific form for a defined monthly cost. This formula accounts for the number of calls per day.

3.3 Service Interruption

Voxcall[®] may interrupt the service at any time for reasons related or unrelated to Voxcall[®] 's liability, including but not limited to, non-compliance with the terms of use by the customer. In these cases, no refund will be made.

Voxcall[®] reserves the right to interrupt its services at any time it deems necessary to perform migrations or technical corrections without it being possible to request a refund.





3.4 Service Termination

Termination of the Discovery formula is not possible as the purchase of call credit is considered a consumable purchase.

Termination of a Professional subscription must be done exclusively from the online contact form on the Voxcall[®] site. Any month started is due. Cancellation of the Professional formula must be received 3 months before the renewal date. Otherwise, the plan will be tacitly renewed.

Article 4: Use of the Service

The service must be used in accordance with these General Terms and Conditions and the terms of use. Clicking the checkbox to accept conditions certifies that the user accepts these terms and is thereby bound.

Any failure may result in an interruption of the service without notice.
