# TERMS OF SERVICE FOR VOXCALL®

#### **DEFINITIONS**

"VOXCALL®" REFERS TO PROFIT TARGET LDA, INCLUDING ITS DIRECTORS, ADMINISTRATORS, EMPLOYEES, AGENTS, AND AFFILIATED ENTITIES.

### **SERVICE DESCRIPTION**

**VOXCALL®** offers an artificial intelligence-managed telephony system along with related services, collectively referred to as the "Service". Access to and use of the Service are governed by these Terms of Service ("Terms").

## **ACCEPTANCE OF TERMS**

By accessing and using the Service, you agree to comply with these Terms. If you do not fully accept the Terms, you may not access or use the Service. These Terms supersede all prior agreements or understandings, whether written or oral, related to the Service.

# **MODIFICATION OF TERMS**
